Tommy W. Lueders, Colonel United States Air Force, retired, died on July 14, 2024. He was born in La Grange, Texas on January 21, 1936, to Judge and Mrs. Theo Lueders. He graduated from La Grange High School and received Bachelor of Business Administration and Doctor of Jurisprudence degrees from the University of Texas.

Football and basketball were an important part of his life in high school and college, and some of his favorite memories were from his freshman teams at the University of Texas. Specifically, he had fond memories of the 1954-55 freshman basketball team that shared the Southwest Conference Championship. Humorously, his favorite football memories while at UT seemingly came while in law school in defeating professor Charles Alan Wright's Legal Eagles team. He competed in rodeo from a young age through college, and enjoyed officiating high school and college football as well as scouting for several teams. Tom enjoyed hunting and fishing from his youth. His retreat was the Colorado River around La Grange where he spent many days and nights hunting and fishing with his family. The Davey Crockett TV show hit the airwayes in 1954, and every red-blooded American boy wanted a coon-skin cap. Tommy spent his free time trapping raccoons for the legion of Davey Crockett fans. He loved teaching others how to hunt and fish and took particular joy in watching his children and grandchildren enjoy the outdoors. Tommy was active in miliary chapels and Lutheran churches and was a member of Shepherd of the Hills Lutheran church in Westlake since 1987.

After law school, Tommy joined the Air Force in 1961, and retired in 1989. He became staff judge advocate after only two years on active duty and served in that capacity four other times. Tommy served in Texas, Alabama, Taiwan, Libya, South Korea, and the Pentagon. He had great experiences and met many lifelong friends during his service. The high point of his career was serving as the Legal Advisor and Legislative Assistant to the Chairman of the Joint Chiefs of Staff for four years, which was a year longer than the standard appointment. He also served as Special Counsel to the Air Force General Counsel. As staff judge advocate of Wheelus Air Base,

Libya, he was the legal member of the United States Embassy team that negotiated with Col. Gaddafi after the Libyan revolution and was the Chief of International Law for the United Nations Command when there was a serious incident at the demilitarized zone in Korea. During the Reagan administration, he served on several interagency groups including serving as legal advisor of the first Anti-Terror Group. His numerous service-related awards include the Legion of Merit with Oak Leaf Cluster and the Defense Superior Service Medal. Tommy was a life member of the American Legion, and the VFW, and served as Chairman of the Military Law Section of the State Bar of Texas.

After a short retirement period, in which he built an addition to his family's Austin home, effectively by himself, Tommy accepted a position as the first Director of Hearings and Review for the Texas Workers' Compensation Commission. He used his experience as a military trial judge and instructor at the Air Force Judge Advocate General's School to rapidly develop a dispute resolution team that, at the time, was regarded as one of the best in the United States. Fighting off retirement as long as possible after leaving the agency he practiced law for another decade. Tommy was a worker. From actually digging a well by hand with the help of several others at his in-law's home in the sandy soil of Alabama, to rebuilding carburetors on the kitchen table, he rarely was at rest and was always building or fixing something.

He married his wife, and best friend, Betty Jo Ezell of York, Alabama, on June 19, 1966, and they had a wonderful life together and have seen the world as a team. From weathering massive sandstorms in Tripoli, Libya, to working together on their beautifully landscaped homes, they have rarely been apart. Tommy is survived by Betty, his wife of 58 years; daughter, Amy Jo (Rod) Dunsmore and their children, Mary, Drew, and Gabe; son, Tommy (Megan) Lueders and their children, Jackson and Carson; and his nephew, Bill (Judge Lorna) Bedard and Chad Ezell; and niece, Tiffanie Ezell. He is preceded in death by his parents, Judge Theodore (Antonio) Lueders; sister, Judge Theo (Judge Bill) Bedard; brother, Rev. Jimmy Lueders; and nephew, Dr. Ted (Melissa) Bedard.

Mr. Speaker, Col. Tommy W. Lueders retired from the Air Force on August 1, 1989, after serving as a judge advocate for over 28 years. He received his bachelor of business administration and doctor of jurisprudence degrees from the University of Texas in Austin. He served as a base staff judge advocate three times, the first after only 2 years of active duty. He was the deputy staff judge advocate at the Civil Air Patrol national headquarters.

After teaching military justice and directing the practice court program at the Judge Advocate General's School, he became the chief of international law for the United Nations Command and United States Forces, Korea, in Seoul, Korea. He returned to Texas and served as deputy staff judge advocate of the 12<sup>th</sup> Air Force at Bergstrom Air Force Base. The highlight of his career was spent as legal advisor and legislative assistant to the Chairman, Joint Chiefs of Staff. At the request of the Chairman, he stayed an additional year. Then he became the first and only special counsel to the Air Force general counsel. He returned to headquarters, 12<sup>th</sup> Air Force as staff judge advocate and concluded his career. We wish Colonel Lueders his wife Betty; and children, Amy and Tommy II, all the best in their future endeavors.
